Little Bennett Campground Rules

- Sites & Yurts: Check-in: 1pm, Check-out: 11am
- Cabins: Check-in: 3pm, Check-out: 11am
- Quiet Hours: 11pm-7am
- Campers must be 18 years of age to reserve a tent or full hookup site and 21 years of age to reserve a cabin or yurt. Children under the age of 13 must be under adult supervision

Refunds

- Cancellations made 14 days or more prior to arrival will receive a full refund.
- Cancellations made at least 3 days prior to arrival but less than 14 days will receive a full refund less a \$25 cancellation fee (\$25 fee applies if you choose to change dates during this time).
 - Cancellations made less than 3 days from the arrival date will not receive a refund.
 - o (i.e., if your reservation begins on a Friday, you have until Tuesday of that week to receive at least a partial refund)

Stays and Guests

- Campers may enjoy a maximum stay of 30 nights on Loop D RV Sites and Cabins and a maximum stay of 14 days on Loops A, B, C and E – Tent sites and Yurts.
- After staying the maximum number of nights, guests must vacate the campground for at least three nights.
- Dogs are permitted in the pet-friendly yurts and cabins. There is a pet fee.
- No more than 2 tents or 1 RV and 1 tent per site. No more than 6 individuals may spend the night at one site.
- Vehicles must be parked on the parking pad at the site. No parking off the gravel or on the road.
- Campground visitors must register and pay at the Camp Store to obtain a visitors parking pass.
- Only registered campers or registered visitors may use the campground facilities and amenities.

Firewood

- Due to the spread of tree-harming invasive species, firewood may not be brought into the campground. Firewood may be purchased at the Camp Store.
- Cutting any standing tree is considered destruction of property and subject to criminal penalty. The use of chainsaws, for any reason, is prohibited.
- Fires are permitted in the fire ring or grill only. First must not be left unattended.

Alcohol Policy

- Beer and Wine are permitted at campsites only and must be concealed.
- No alcohol is permitted in common areas of the campground.
- No liquor is permitted on campground property.

Other Important Information

- Picnic tables are not to be moved
- Pets are permitted if kept on a leash. Pets may not be left unattended, and waste must be cleaned up.
- Dishes should be washed at your site or in your camper NOT at the water spigot OR bathhouses
- Refer to the Montgomery County Parks Rules and Regs Chapter IV, Section 15 regarding weapons.
- Permits may be revoked without refund for failure to follow these rules and regulations

Rental Pavilion & Rental Group Site Rules

- Maximum capacity for Pavilion and Group Fire Ring is 40 people
- Setup and cleanup must take place during the reserved time
- Alcohol is NOT permitted at the pavilion or Group Fire Ring only at campsites
- Permit holder is responsible for removing all decorations and trash before the rental period ends. If the pavilion or Group Fire Ring area need excessive cleanup, a \$50 charge will be added to your permit.
- Loud, offensive, or excessive noise which disturbs other park patrons is not permitted.
- Vehicles must be parked in the nearest parking lot to the Pavilion and Group Fire Ring. Driving on the grass is prohibited. No parking is permitted on the shoulder of the roads. If the parking lot is full, please park in the Maintenance Yard parking lot (enter from Frederick Road) and walk over or coordinate to be picked up
