### **Lottery Managed Deer Hunting Program Pre-Screening Information**

Thank you for your interest in the M-NCPPC, Montgomery Parks Lottery Managed Deer Hunting Program. The following is a description of the program and instructions for how to seek approval to participate. Please read this information carefully and fill out the required forms completely. **PLEASE NOTE: Pre-Screening Application forms are accepted throughout the year with a deadline of the first Friday in June for the upcoming program year. Pre-Screening Applications received after the first Friday in June will not be considered but will be retained for consideration for the following program year. Participation of individuals under the age of 18 years is limited to lottery- based shotgun hunting at Little Bennett Regional Park, only. Participants under 18 must be accompanied by their parent or designated guardian/mentor.**

In an effort to relieve impacts resulting from deer in and around select parks, Montgomery Parks conducts deer population management programming. The first managed deer hunts for the Department of Parks occurred in December 1996. Foremost objectives are to maintain safety and to harvest an appropriate portion of the deer population annually, to achieve a stable or negative population growth rate. Though primary objectives are focused on management, we work hard to provide participants with a quality hunting experience and success. This program allows for shotgun hunting at select park locations and archery hunting at other park locations, both methods occur during the fall and winter months. All parks, except for one, require treestand hunting, only. One park allows for hunting from the ground OR from a treestand (though treestands are recommended). For shotgun hunting, shot range is restricted to 80 yards or less, whereas archery hunting shot range is restricted to 30 yards or less. Individuals who intend to participate in either, or both, the shotgun element and/or the archery element are required to pass Shooting Qualification test(s) with the applicable hunting implements, annually.

In an effort to uphold the Department's priority of program goals (Safety, Management Objectives, Hunter Satisfaction) We seek participants who:

1. Understand and support the objectives of the Montgomery Parks Deer Management Program.
2. Will prioritize safety and regulations above personal interests.
3. Are experienced, safe hunters capable and willing to harvest multiple antlerless deer.
4. Are consistent, reliable, and willing to dedicate time and effort under a variety of conditions.

**In order to be approved to participate in the Department's Managed Deer Hunting Lottery, all applicants must first submit the attached waiver and questionnaire as well as demonstrate proof of completion of a State hunter education/safety course (photocopy of certificate and/or card required; numbers by themselves will not be accepted). Additionally, for those intending to apply for the archery element of the Lottery Program, applicants must also provide proof of State-sanctioned and/or NBEF Bowhunter Education Certification. No other exceptions.** Staff will review the Pre-screening questionnaire for knowledge of safety practices, regulations, deer hunting experience, and ability to read/comprehend and follow instructions etc. In addition, a background check will be required at the applicant's initiation and expense (\$18.50) to investigate prior infractions that might compromise the integrity of the managed deer-hunting program. See instructions, below.

Following staff review, applicants will receive notification informing them of approval or denial to participate. Assuming that there is no reason for dismissal from the program, applicants

need to be approved only once to apply to the hunt lottery, annually. If approved, during the last week of June or first week of July each year, participants will receive Lottery Application materials to participate.

Correspondence occurs by email, only. Detailed information regarding participation requirements and procedures will be included in these application materials prior to the lottery and/or in the selection materials issued following the lottery. **[NOTE:** If you are denied the opportunity to apply, you may continue to submit the pre-screening packet to try to become approved (unless otherwise indicated). However, you may only submit one pre-screening application per season.]

5. Driver's License or Passport [If under 18 years of age, photo I.D. such as a passport, student I.D., or driver's permit/license if available].

### **Statement of Hunter Ethics & Waiver of Liability**

As an approved participant of the M-NCPPC Montgomery Parks Managed Deer Hunting Program, I hereby agree to always adhere to the hunter ethics standards below while hunting or scouting:

- I will obey all the Maryland Department of Natural Resources (hereinafter referred to as “DNR”) Hunting Regulations and follow all Maryland-National Capital Park and Planning Commission (“hereinafter referred to as the M-NCPPC”), Montgomery Parks Rules and Procedures.
- I will respect members of the public while participating in scouting and hunting activities.
- I will respect the rights of other participants at all times.
- I will take the utmost precaution to assure the safety of others and myself.
- I will honor the Department’s priority of program goals (Safety, Management Objectives, Hunter Satisfaction) and place them ahead of my personal, recreational goals.

#### **For Shotgun Participants:**

- I will use rifled slugs or sabot slugs of 20 gauge – 12 gauge, only.
- I will make every effort to avoid unnecessary wounding of wildlife and will shoot at stationary targets **less than 80 yards, only.**

#### **For Archery Participants:**

- I will only use modern archery tackle (compounds and/or crossbows) as approved for deer hunting in the State of Maryland and the M-NCPPC Montgomery Parks Managed Deer Hunting Program
- I will make every effort to avoid unnecessary wounding loss of deer and will shoot at stationary targets **less than 30 yards, only.**

#### **Assumption of Risk and Indemnification**
