Dear Tennis Patron:

It is tennis lottery time again! If you'd like to put your hat in the ring for court time at Pauline Betz Addie Tennis Center for the coming 32-week season, we hope you'll look through the enclosed packet. It contains important information about the lottery for the 2024-2025 season, which will run September 3, 2024 through April 14, 2025. Please read it over carefully and fill out your application completely and legibly. If you have any questions, please call 301-765-8650 and ask to speak to the manager or email PBATennis@montgomeryparks.org. Your application must be received at Pauline Betz Addie Tennis Center by 7pm on Tuesday, February 27, 2024. We cannot be responsible for the late arrival of mailed applications, so be sure to mail early.

Some rules and regulations...

Applicants who are awarded court time through the lottery process but then decide *not* to use their court will forfeit their \$100.00 application payment and must return the court time back to Pauline Betz Addie Tennis Center prior to March 31, 2024. Selling seasonal court time to another party is strictly prohibited.

And our refund policy...

Refunds can only be given for unused court time to applicants who can no longer fulfill their commitment to the tennis facility due to medical reasons. In this case, a doctor's note verifying the medical concerns must accompany the refund request. Once seasonal court time is allocated, changes to dates or times will not be accepted, so please consult your calendars before making your court time choices on the Application.

2024-25 LOTTERY APPLICATION INSTRUCTIONS

STEP 1: Fill out your APPLICATION

For one hour of court time: *Each individual applicant may apply for one hour of court time only.* Complete all information in the "Applicant #1" section of the Application, including your choice of day and starting time (on the hour only), plus a second and third choice if you like. You may be very general with your choices (for example, Monday, anytime between 1:00-5:00 p.m. as your first choice) but please be prepared to accept whatever time is allotted within that time frame.

For two consecutive hours of court time: Fill out the "Applicant #1" section of the Application, and a second person (your tennis partner) fills out the "Applicant #2" section of the *same Application*. Applicant #1 will be assigned your one-hour first, second, or third choice, if available, even if the second (consecutive) hour requested by Applicant #2 is not available.

If you are interested in a two-hour block only (and not interested in a one-hour block at all), please check the red box at the bottom of the form. In this case, both applicants will receive refunds (see Step 4) if two hours are unavailable as a block. We cannot fill requests for 1½-hour time blocks.

To make the lottery both equitable and expeditious, please submit *only one application per person*. Multiple applications will be disqualified, and you will not be eligible for any 2024-25 seasonal time. If you are awarded time, and later we find a second application was submitted, your awarded time will be revoked.

STEP 2 – Submit your APPLICATION and DEPOSIT *Deadline: 7pm on Tuesday, February 27, 2024*

Submit your application in an envelope with your name, return home address, email and "TENNIS LOTTERY" clearly and legibly marked on the outside. Applications must be received by **7pm on February 27, 2024** at Pauline Betz Addie Tennis Center (7801 Democracy Blvd., Bethesda, MD 20817) to be included in the lottery. Applications may be mailed or dropped off at the Tennis Center. We cannot be responsible for the late arrival of mailed applications, so please mail early. Each Applicant must submit a \$100.00 check, made payable to **ActiveMONTGOMERY**. The name on the check must match the Applicant name on the Application. If two applicants apply for two consecutive hours of court time, both Applicant #1 and #2 must submit **separate**, pre-printed checks for \$100.00 with the Application.

STEP 3 – COURT TIMES are assigned *Results posted Monday, March 4, 2024*

The lottery begins on Wednesday, February 28, 2024. Requests will be allocated, and applicants will be given one of the three choices of court times from their application until all requests are filled, or all available times have been reserved. Incomplete or illegible forms cannot be considered. No more than one hour will be assigned to any one individual until after March 25th.

REMINDER: We are required to deposit your \$100 check upon receipt. If you receive court time, the \$100 will be applied to your total court fee. If you do *not* receive one of your three-time choices, we will contact you to try to find an acceptable alternative. If we cannot find a workable slot, we will issue a refund check (please allow 10-14 business days) or leave the \$100 credit on your ActiveMONTGOMERY account. Contracts will be emailed by **Friday, April 5, 2024**.

STEP 4 – Make your FINAL PAYMENT *Deadline: Friday, June 14, 2024*

All permit invoices for seasonal court time will be emailed or mailed to the individual in whose name the one hour of court time is reserved (i.e. one contract and contract holder per one hour of court time = one permit invoice to and one payment from that contract holder). Payment can be made by 1) Visa, MasterCard, Discover and American Express online at ActiveMONTGOMERY.; or 2) in person at Pauline Betz Addie Tennis Center with Visa, MasterCard, Discover, American Express, cash, or personal check (a single personal check for the balance due, pre-printed with the court holder's name and address). If you received two consecutive hours, two permit invoices will be sent out and two separate payments will be accepted. **PLEASE NOTE: A 10% late fee** will be added to any balance not paid in full by June 14, 2024. If the total account balance is not paid by **Friday, June 28, 2024**, the court time will be canceled and resold and the deposit forfeited.

Tuesday, December 24	No seasonal court time, Christmas Eve
Wednesday, December 25	Facility closed for Christmas.
Tuesday, December 31	No seasonal court time, New Year's Eve
Wednesday, January 1, 2025	No seasonal court time, New Year's Day
