- **Physical Access:** Keeping up with ADA standards, take reasonable steps to remove barriers, establishing projects to create equal opportunities within our parks.
- Web & Digital Accessibility: Establishing equal access, following Web Content Accessibility Guidelines (WCAG), and fulfilling reasonable accommodations.
- **Employment Accommodations:** Providing reasonable adjustments for employees with disabilities through an interactive process.
- **Program Access:** Providing support services to activities within our parks for individuals with disabilities, maintain effective communication, and promote inclusivity throughout all programs.

Physical Access

- 36 Parks are now categorized as fully or generally accessible.
- Total of over 3,000 barriers are removed from Parks.
- 9 projects were completed including a new community garden at Black Hill, an accessible Bike Track facility at South Germantown, and the well-used boat landing area at Seneca Landing Special Park.
 - Other ADA improvements being done or under construction include restrooms, playgrounds, circulation paths, parking lots, fields, courts, etc. A couple of parks received ADA improvements throughout the park.










DATA PRE + POST COVID


Disabilities Served in 2023

Accessibility at Special Events in 2023

Appropriate adaptive equipment and sign language interpretation is available on-site at larger events.

Our high demand services this year were the Sensory Retreat Tent and the Accessible Shuttle Cart. Taking in account cancellations due to weather, the Sensory Retreat Tent was available at 9 events and the Accessible Shuttle Cart was used at 17 events.

Adaptive Paddling Equipment

In collaboration with Team River Runner, a non-profit organization, Parks can provide users with a **seating system** that provides additional support and balance where needed; **stabilizing outriggers** that mount to the back of a boat to provide extra balance and buoyancy and; **paddle pivots** that provide a pivot point around which the paddle stroke can happen and allows one handed paddling.



NEW Adaptive / Therapeutic Recreation Programs



Adaptive Paddling

Tailored for individuals with disabilities and their accompanying family or friends, this program offers an inviting and accessible experience.



Trail Trekkers

This free program, designed for individuals with disabilities and their friends, family, and community members, takes place at various accessible trails within Montgomery County, providing participants with the opportunity to immerse themselves in diverse natural surroundings and engage in conversations with fellow trekkers while creating long-lasting friendships.



55+ Programs in 2023

Participants learned basic strokes, entries and exits, boat control, and more, taught by certified American Canoe Association instructors.
