

2024-2025 Seasonal Court Time Lottery Application Instructions

Please read carefully, and call us at <u>301-905-3030</u> or Email WheatonIndoorTennis@MontgomeryParks.org if you have questions.

STEP 1: Complete your application

- Complete the 'Applicant #1' section of the form. Include your preferred day and starting time, with second and third choices if desired.
- You may provide general choices (e.g., Monday, anytime between 1:00-5:00 p.m.), but be prepared to accept any time within the time frame.
- To apply for two consecutive hours of court time, fill out the 'Applicant #1' section and have your tennis partner fill out the 'Applicant #2' section.
- If you only want a two-hour block, check the red box at the bottom of the form.
- Each person may only apply for one hour of court time. Individuals who submit multiple applications will be disqualified.

STEP 2: Submit your application and deposit Deadline: 7 p.m. on Tuesday, March 26, 2024

- Include a \$100 check, payable to ActiveMONTGOMERY, from each applicant.
- If you apply for two consecutive hours, each applicant must submit a separate check.
- Seal your application in an envelope with your name, address, email, and "TENNIS LOTTERY" printed on the outside.
- You can hand deliver or mail the application to Wheaton Indoor Tennis, 11715 Orebaugh Ave., Wheaton, MD 20902.
- Applications, including mailed applications, must be received by 7 p.m. on Tuesday, March 26, 2024.

STEP 3: Receive your court time Results posted Thursday, March 28, 2024

- The lottery drawing will be on Wednesday, March 27, 2024.
- We will award requests in order as we draw them until we fulfill every request or exhaust every option.
- We will try to find an alternative if you do not receive one of your original selections.
- If we cannot find an alternative, we will refund your deposit via check or credit on your ActiveMONTGOMERY account.
- We will email the contracts by Friday, April 12, 2024.

STEP 4: Pay your balance Deadline: Friday, June 14, 2024

- We will email invoices to each person who receives court time.
- We require two separate payments for two-hour contracts.
- You can pay online or in person with cash, a credit card, or a personal check.
- We will assess a 10% late fee for any balance not paid in full by June 14, 2024.
 If you do not pay the total balance by Friday, June 28, 2024, you will forfeit your court time and not receive a refund.
